- Agency: Since 2018 there has been a 17% decrease in the number of Agency settlements and an 98% increase in total Agency settlement cost. In 2018, we had a total of 30 Agency settlements processed by OSHR. These totaled to a cost of \$589,134.71.
- **University**: University settlements saw no change in the number of settlements and a 33% decrease in total cost. There were 8 university settlements totaling \$338,295.51 in 2018.
- **Overall**: In total there has been a 13% decrease in number of settlements and a 50% increase in total settlement cost. In 2018 OSHR processed 38 settlements costing \$927,430.22.
