SUBJECT: Experience Credit for NC Child Welfare

**Collaborative Graduates** 

The purpose of this memorandum is to confirm the approval of the recommendations submitted by the North Carolina Child Welfare Education Collaborative to recognize experience credit for individuals who have successfully completed the NC Child Welfare Collaborative program. The Office of State Personnel supports the recommendations for the granting a year of work experience credit for completion of this specialized program towards qualifying for the Social Worker II and Social Worker III classifications. The experience credit can only be applied to social work positions assigned to child welfare programs. Illustrated below are the applications of the academic credit for the Social Worker II and Social Worker III classifications.

### Social Worker II

Applicants who possess a Bachelors degree in Social Work (BSW) and have successfully participated in the NC Child Welfare Collaborative Program qualify for the Social Worker II classification upon graduation. Applicants with a BSW who did not participate in the NC Child Welfare Collaborative program would still need to meet the required one year of social work or counseling experience to qualify for this classification.

## Social Worker III

Applicants who possess a Masters degree in Social Work (MSW) and have successfully participated in the NC Child Welfare Collaborative Program qualify for the Social Worker III classification upon graduation. Applicants with a MSW who did not participate in the Child Welfare Collaborative program would still need to meet the required one year of social work or counseling experience to qualify for this classification.

Please note that any of your current employees who have a BSW or MSW and have successfully participated in the NC Child Welfare Collaborative program should be given experience credit as described above in order to fairly and consistently apply this new qualifications guideline. Graduates who have completed the program will have received a certificate documenting their participation.
