## What Benefits do you have?

- Be aware of the benefits you have and through who
  - Medical is State Health Plan ◆
  - You may have post-tax plans through your employer (check with HR)
- NCFlex benefits include the following:
  - Health Care FSA or Dependent Day Care FSA (P&A Group)
  - Accident, Term Life, AD&D (Voya)
  - Cancer or Critical Illness (Allstate)
  - Dental (MetLife)
  - Vision (EyeMed)
  - Disability (The Standard) only for Non-University employees
  - TRICARE Supplement (Selman & Company)

## When do Benefits End as an Employee?

- NCFlex benefits:
  - End of the month you leave employment as long as there is enough money to take a premium.
- State Health Plan:
  - End of the month you leave employment OR end of the next month, depends on your date of separation – check with Human Resources.
- Employer sponsored benefits check with Human Resources



#### **COBRA vs. Portability**

#### COBRA Coverage:

- Stands for: The Consolidated Omnibus Budget Reconciliation Act of 1986
- Applies to health plans: Medical, Dental, Vision, and Health Care FSA
- Allows you and your dependents to continue current coverages <u>for a specific period</u> when you or your dependents are enrolled, and coverage is lost due to a qualifying event. You must pay the required cost of coverage.
- Cost is contracted rate plus 2% fee.

#### Portability or Continuation

- If you meet eligibility requirements, such as age, you and your dependents can move current coverage directly under vendor, paying them going forward.
- Applies to Accident\*, Cancer\*, Critical Illness\*, Term Life, Voluntary AD&D, and TRICARE Supplement\*.
- \*Cost for these products is same as you are paying as an employee.



#### **COBRA Periods**

The following charts show the coverage provisions — except for the duration of coverage for the HCFSA, which can only be continued to end of the plan year.

Qualifying Event	Qualified Beneficiaries Who May Continue Coverage	Duration of Coverage
You retire or your employment ends for any reason other than gross misconduct	Yourself, spouse, dependent children	Up to 18 months
During the first 60 days of COBRA coverage the employee or his/her dependent becomes disabled under the Social Security Act	Yourself, spouse, dependent children	Up to 29 months; months 1-18, 102% of premium; months 19-29, 150% of premium
You divorce or legally separate	Ex-spouse and/or dependent children	Up to 36 months from initial qualifying event
Your dependent children lose eligibility	Dependent children	Up to 36 months from initial qualifying event
You become covered by Medicare	Spouse and/or dependent children	Up to 36 months from initial qualifying event
You pass away	Spouse and/or dependent children	Up to 36 months from initial qualifying event



## **Continuing Flexible Spending Accounts**

- Health Care FSA COBRA
  - Can be continued after separation through the end of the plan year
  - Continuation is on a post-tax basis and includes a 2% fee
  - Gives you more time to use your funds
- Health Care FSA Not continued through COBRA
  - Money <u>not used</u> that was contributed <u>is lost</u>
    - Ex. You retire 8/1/21, you elected \$1200 for the year and have now contributed \$800, but have only used \$500 the other \$300 is lost unless you file a claim before the filing deadline (more on next slide)
  - Money used above what was contributed is not owed back to the plan
    - Ex. You retire 8/1/21, you elected \$1200 for the year and have contributed \$800, but you've used \$1200 the additional \$400 is not owed back to the plan.



#### **Continuing Flexible Spending Accounts (cont.)**

- Claims must be dated on or before the end of the month you last worked (or last premium was taken) – you still have until the filing deadline of the plan to file claims.
  - Ex. 2021 filing deadline is 3/31/23, so if you retire 8/1/21, claims must be dated on or before 7/31/21, and you have until 3/31/23 to file those claims.

#### Dependent Day Care FSA

- Contributions cannot be continued after separation
- However, participants can continue filing claims on the money already contributed prior to separating – through the end of the plan year. Claims will need to be submitted to the vendor by the filing deadline.



#### **Porting Age Restrictions**

- Accident Plan, Term Life, and Voluntary AD&D (Voya products)
  - Portability must be elected prior to age 70
  - For Term Life, conversion is also available
  - o For Term Life, after age 70, conversion is the only option
- Benefit After Age 75 Term Life and Voluntary AD&D
  - The amount of coverage will decrease to 50% when you turn age 75 (your spouse's coverage will also decrease upon you turning age 75). Coverage cannot be increased once coverage is reduced due to age.

#### **Making Changes to NCFlex Plan**

- You can enroll in NCFlex plans:
  - As a New Hire/Newly eligible or
  - At Open Enrollment each year (usually in October, this year is Oct. 11 29 for the 2022 plan year).
- Outside of these two occurrences, changes can be made when you experience a Qualifying Life Event.
  - You have 30 days from the day of the event to make a change.
  - Changes are effective the 1<sup>st</sup> of the following month from your life event.
  - Changes made must be consistent with the life event certain rules apply to changes that are allowed.



## Making Changes to NCFlex Plan (cont.)

- All Flexible Spending Account election increases or decreases are still subject to the plan year maximums and minimums as mentioned in the employee Enrollment Guide.
  - New amounts cannot go below what has been contributed to the plan or reimbursed by the plan.
- Changes that <u>may</u> be allowed: adding plans, removing plans, adding or removing dependents, increasing or decreasing coverage amounts (such as Term Life\*).
  - \*Evidence of Insurability may be required
- Changes not allowed: moving between plan tiers. Ex. Changing from low to high dental, basic to enhanced vision, or high to premium cancer plan.
  - Exception if you are enrolled in Core Vision and need to add dependents.



#### **Life Events**

- Marriage
- Birth, Adoption, Legal Custody or Guardianship
- Death of a Dependent
- Divorce or Legal Separation
- Loss of other coverage
- Now eligible for other coverage
- Leave of Absence and Return from Leave of Absence
- Military Leave
- Reduction in Hours
- Dependent Day Care Change



#### **Life Events – How to Make a Change**

 Contact your HR department or Benefits rep if you have any questions about what changes are allowed due to certain life events.

- To make a change, go to the Benefits Enrollment Platform.
  - Some HR systems have a single-sign-on to the platform.
