Benefits of Choosing NCFlex Dental

Employee Only	\$51.78	\$35.90	\$23.14
Employee and Spouse	\$103.84	\$72.00	\$46.64
Employee and Child(ren)	\$112.00	\$78.00	\$50.08
Employee and Family	\$183.36	\$123.00	\$79.84



Examples of 25% Pre-Tax Savings

As a reminder, premiums come out of your paycheck Pre-Tax, saving you money.

	Monthly Premium	Monthly Pre-Tax Cost	Monthly Tax Savings	Annual Tax Savings
Dental Classic EE Only	\$35.90	\$26.93	\$8.98	\$107.76
Dental High EE + Family	\$183.36	\$137.52	\$45.84	\$550.08
Dental Low EE + Children	\$50.08	\$37.56	\$12.52	\$150.24



Dental – Network Savings

Procedure Fee Look Up Tool:

- Get Procedure Code from Dentist
- Go to <u>feelookup.com</u>
- Type in Zip Code
- Scroll through to find Procedure Code
- Compare cost between In-Network vs. Out-of-Network


In-Network Savings Example (High Plan)

This hypothetical example of **needing a crown**, shows how receiving services from a participating dentist can save you money.

Dentist's usual charge	\$1,462.00	\$1,462.00

R&C fee	N/A	\$1,451.00	
The plan pays (50%)	\$340.00	\$725.50


Step 1: Go to metlife.com/mybenefits and enter "NCFlex: as the company name, click "Next"

MetLife Travel Assistance

MetLife provides International Dental Travel Assistance services tied to the dental benefits you already receive.

- Availability to multilingual assistance coordinators 24/7/365;
- Toll-free calling within the U.S. or collect calling outside the U.S. (312-935-3500);
- Access to providers in more than 200 countries;
- Providers selected based upon strict credentialing criteria, including:
 - Western Dental training, i.e., dentists who have completed dental school residency or a portion of their training in the U.S., Western Europe, United Kingdom or Canada;
 - Local accreditation, including specialties covered and staff experience;
 - Willingness to adhere to the program's quality guidelines;
 - Experience working with foreign patients and English-language proficiency, depending on the country;
 - Access to the technology needed to provide adequate assistance;
 - Patient care environment.



MetLife Travel Assistance (continued)

- MetLife does not require pre-authorization for non-emergency services occurring outside of the U.S., but they do recommend it.
- Reimbursement: Coverage will be considered under your out-of-network benefits. Please remember to retain all receipts to submit a dental claim.
- Please note that MetLife does not maintain an online provider file for dentists located outside of the U.S.
- If you are in the U.S. and planning an international trip, call 1-888-558-2704 for help in locating a participating dentist. If you are traveling within the U.S., please visit www.metlife.com/mybenefits and enter NCFlex as the company name to find a participating dentist.

MetLife Mobile App

- Find a dentist
- Get estimates for most procedures enhanced to display personalized, plan specific costs and additional information such as percent covered, applicable deductible, Plan Maximum and Frequency Limits
 - In-network and out-of-network estimates are available
- View your plan summary including deductibles, plan maximums, covered services, and frequency limits





MetLife Mobile App (continued)

- View your claims
- Track your brushing and flossing
- Access and save ID card to photo library or mobile app
