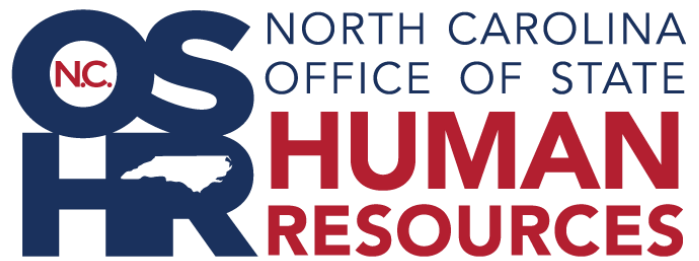

# STATUTORY REQUIREMENT

N.C.G.S. § 126-6.3(a6) requires the Office of State Human Resources (OSHR) to report quarterly, beginning January 1, 2024, “to the Joint Legislative Oversight Committee on General Government and to the Fiscal Research Division on agency compliance with this section and policies and rules adopted pursuant to it, including:

1. “The number and type of all exceptions made by the Director of the OSHR.
2. Any agency invoices with due dates greater than 60 days.
3. Compliance with G.S. §147-86.11(e)(3) through (e)(4).
4. The number of temporary employees who exceeded 11 months of consecutive employment, and the number of days each employee exceeded 11 months of employment, separated by State agency.”

Temporary Solutions, a program of OSHR, hereby submits this report for the period April 1, 2025 – June 30, 2025.

## COMPLIANCE REPORT

### **1. The number and type of exceptions made by the Director of OSHR (N.C.G.S. § 126-6.3(a6)(1))**

#### Exceptions on the use of Temporary Solutions by Cabinet agencies

Ordinarily, “all Cabinet agencies that utilize temporary employees to perform work that is not information technology related shall employ them through the Temporary Solutions Program administered by the Office of State Human Resources (OSHR).” N.C.G.S. § 126-6.3(a). N.C.G.S. § 126-6.3(a3)(1) states: “The Director of the OSHR may create exceptions to the requirements of subsection (a) of this section only when the following conditions are met:

- a) “The Temporary Solutions Program cannot meet the agency’s employment needs for a class of temporary job assignments.
- b) Failure to recruit for the class of temporary job assignments will cause severe harm to the agency’s ability to provide services to the public.”

No new exceptions were made under G.S. § 126-6.3(a3)(1) between April 1 – June 30, 2025. Please see the report sent on September 30, 2024, for the exceptions that were previously approved and are in place for FY 2024-25.

#### Exceptions to 11-month limit for temporary employees

N.C.G.S. § 126-6.3(a1) states: “No temporary employee shall be employed more than 11 consecutive months. A temporary employee shall only be eligible for reinstatement on the job assignment after working 11 consecutive months if the temporary employee is separated for at

least 31 consecutive calendar days.” N.C.G.S. § 126-6.3(a3)(3) states the conditions under which an exception can be made to the 11-month limit:

“The Director of OSHR may create exceptions to the requirements of subsection (a1) of this section only when all the following conditions are met:

- a) “The exception is in the best interests of the State because removing the employee from the job assignment will cause severe harm to the agency's ability to provide vital services to the public.
- b) The exception will not result in extending the 11-month maximum length of temporary employment beyond 22 months from the employee's initial hire date.”

The Director of OSHR made seven exceptions under N.C.G.S. § 126-6.3(a3)(3).<sup>1</sup>

The Department of Administration (DOA) received an exception to the 11-month limit for a temporary Community Development Specialist I. DOA demonstrated in its exception request that removing the temporary employee from the job assignment would cause severe harm to the agency's ability to provide vital services to the public. Specifically, the employee served as the temporary Program director for the Tobacco Survey Program, which collected information about tobacco and vaping use among American Indian communities in North Carolina and delivered prevention initiatives. The program lost funding due to federal funding reduction and the two temporary positions supporting the temporary program director were discontinued. The funding for the temporary Program Director's position was changed to another funding source – Joule Settlement Funds for Youth Tobacco/Vaping – so that the program could continue its work. These funds were scheduled to expire on September 30, 2025. DOA determined that if the temporary program director took her mandatory break, there would be no one to provide program services during her 31-day separation, which would “severely hinder the agency's progress with the Program, communications, and health awareness support provided to North Carolina's American Indian communities,”

The Department of Natural and Cultural Resources (DNCR) received an exception to the 11-month limit for a temporary Research Historian with the NC African American Heritage Commission. DNCR demonstrated in its exception request that removing the temporary employee from the job assignment would cause severe harm to the agency's ability to provide vital services to the public. Specifically, the employee's temporary position was funded by a federal grant from the Institute of Museum and Library Sciences (IMLS). During her temporary assignment, the employee conducted research on Blackbeard's *Queen Anne's Revenge* ship. The employee's research concluded with her “completing a white paper detailing all of her efforts over the last two years and an article to be published in the NC Historical Review,” The Commission Director explained, “[The commission] received explicit correspondence from IMLS ... that if our deliverables for this work were not completed and the closing paperwork filed that it would compromise our ability to receive federal grants in the future. These grants

have been a vital component to the work of [the commission]. Over the last several years, we have received over a half a million dollars for numerous projects. As we receive limited recurring funding from the legislature, these funds are critical to our work and they would not happen without federal funding. This funding provides services to create K-12 educational resources, free traveling exhibits for museums and community spaces across the state, research, creating pathways for young professionals in our field, public programming, and more.”

The Department of Health and Human Services (DHHS) received an exception to the 11-month limit for a temporary rules review manager with the Division of Health Service Regulation (DHSR). DHHS demonstrated in its exception request that removing the temporary employee from the job assignment would cause severe harm to the agency’s ability to provide vital services to the public. Specifically, the employee’s temporary position coordinated all rule-making activity for DHSR and its approximately 1,650 rules. DHHS explained that “during the ... scheduled 31-day break there are deadlines and meetings for rules associated with the following types of licensed healthcare facilities: ambulatory surgical facilities, hospice providers, home care agencies, and hospitals. In addition to the rules for the foregoing types of healthcare facilities, there are numerous responsibilities for [the temporary employee] to fulfill during this time period including public hearings for the adult care rules and a series of meetings regarding the radiation protection rules for the RPC (Radiation Protection Commission) including public hearings as well as submissions to the RPC. DHHS further explained that the break would impact “enforceable rules regarding radioactive materials and also [create] the potential for the NRC [Nuclear Regulatory Commission] to limit NC’s future authority under the current Agreement between NC and the NRC” and “result in the potential for serious harm to the safety of patients, clients, and residents served by the DHSR regulated facilities.”

The Department of Justice (DOJ) received an exception to the 11-month limit for two temporary employees: a temporary attorney III and a temporary administrative assistant. DOJ demonstrated in its exception request that removing both temporary employees from their job assignments would cause severe harm to the agency’s ability to provide vital services to the public.

Specifically, the temporary attorney III was responsible for preparing one-half of the condemnation complaints for the NC Department of Transportation (DOT) each week (approximately 12-13 claims). Five weekly filing deadlines would have been impacted during her break period, causing the filings for the separation to be reduced from approximately 125 files to 65 filings. The temporary administrative assistant was responsible for preparing and filing pleadings each week and transmitting pertinent documents to the DOT, partners, and to the Clerk of Courts and Register of Deeds Office. Like the temporary attorney III, the temporary administrative assistant was responsible for one-half of the condemnation claims filed for the DOT each week (approximately 12-13 claims). Five weekly filing deadlines would have been impacted during her break period, causing the filings for that period to be reduced from approximately 125 filings to 65 filings. As documented in the DOJ exception request, “If the mandatory separation period is not waived then, with the remaining personnel, our office will only be able to file 13 cases each week, resulting in a backlog of 12 cases each week of the separation periods or 120 cases that will be delayed. While there may be more than one case connected with a particular construction project, there will likely be dozens of projects that will be delayed due to the DOT not owning the property needed for construction. These delays will

severely disrupt our services to DOT and DOT's delivery of vital infrastructure to the citizens of North Carolina.”

The Department of Administration (DOA) Council for Women and Youth Involvement (CFWYI) received an exception to the 11-month limit for two temporary employees: a temporary program coordinator II and a temporary program coordinator I. DOJ demonstrated in its exception request that removing both temporaries from their job assignments would cause severe harm to the agency's ability to provide vital services to the public. Specifically, DOA explained in the exception request that both employees were focused on managing federal Family Violence and Prevention Services Act (FVPSA) supplemental American Rescue Plan Act grant funds with a period of performance that ended on September 30, 2025, and a liquidation date of December 31, 2025, and that their wages were covered by CFWYI's 5% administrative share of those federal funds. DOA explained, “To lose the services of two FTEs responsible for administered those subgrants, including reviewing and approving subgrantee reimbursement reports, so close to the end of the project period would severely impair CFWYI's ability to assist ... subgrantees (including domestic violence shelters and violence prevention programs) in spending down these vital non-recurring federal funds. [With an approved exception, CFWYI] will have their critical assistance in processing final reimbursement requests and closing out the supplemental grants before the December 31, 2025 liquidation deadline.”

## **2. Any agency invoices with due dates greater than 60 days (N.C.G.S. § 126-6.3(a)(2))**

When a temporary is employed through and paid by Temporary Solutions, the employing state agency receives invoices from Temporary Solutions that include:

- The amount paid to the temporary.
- The employer portion of the FICA tax.
- The employer premium for High-Deductible Health Plan coverage if the temporary is enrolled.
- An administrative charge of \$2.00 per hour of time worked by the temporary. The charge funds the operations of Temporary Solutions, a 100% receipt-supported program.

N.C.G.S. § 147-86.21 requires state agencies to which an account receivable is owed to collect the account receivable according to internal policies and procedures that are consistent with statewide policies and procedures adopted by the state controller. Temporary Solutions issues past due notices to employing agencies when an invoice is 30 days past due (First Notice) and 60 days past due (Second and Final Notice). Additionally, Temporary Solutions issues the employing agency a “Notice of Pending Referral to the Attorney General's Office” when an invoice is approximately 75 days past due and sends a Statement of Account to each agency HR Director and CFO every month. The Statement of Account is a list of all unpaid open invoices, including those that are current and past due.

Table A identifies, for the period ending June 30, 2025, the number of invoices that were more than 60 days past due, by agency. For a detailed list of these invoices, including the invoice

number, state agency, number of days past due, and amount of each invoice, please see Appendix 1.

As shown in Appendix 1, the average unpaid amount of invoices that were greater than 60 days past due was \$1,770.47.

Table A also identifies whether any of the past due invoices shown required agencies to be suspended from acquiring new temporary employees under N.C.G.S. § 126-6.3(a2), which reads, effective June 28, 2024:

“The OSHR shall prohibit from acquiring new temporary employees any agency or division, based on individual budget code, having an invoice owed to the OSHR that is

over 90 days overdue and a total overdue invoice amount exceeding two hundred thousand dollars (\$200,000). When an agency or division, based on individual budget code, is restricted from acquiring a new temporary employee under this subsection, the agency or division shall not be allowed to acquire new temporary employees through the Temporary Solutions Program until the agency or division has paid all invoices that are over 90 days overdue. The provisions of this subsection do not apply to the North Carolina National Guard.” N.C.G.S. § 126-6.3(a2), as amended by Session Law 2024-23, Section 10.

As shown in Table A, there were no agency Divisions, based on individual budget code, that had, during the reporting period, at least one invoice that was greater than 90 days past due and a total past due balance exceeding \$200,000.

N.C.G.S. § 126-6.3(a3)(4) allows the Director of OSHR to grant an exception to the overdue invoice response process set out in N.C.G.S. § 126-6.3(a2). During the quarter discussed in this report, there were no exceptions granted under N.C.G.S. § 126-6.3(a3)(4).

### 3. Compliance with N.C.G.S. § 147-86.11(e)(3) through (e)(4)

N.C.G.S. § 147-86.11(e)(3) states: “Moneys due to a State agency by another governmental agency or by private persons shall be promptly billed, collected and deposited.”

Temporary Solutions generates invoices prior to each biweekly pay day. This process typically takes one to two business days. Once the invoices are generated, they are distributed to each agency in SharePoint. This process typically takes five to seven business days.

Table B identifies, during the period April 1 – June 30, 2025, the pay period, the date of each biweekly pay day, the date that invoices were generated, and the date that invoice distribution was completed.

N.C.G.S. § 147-86.11(e)(4) states:

“Unpaid billings due to a State agency other than amounts owed by patients to the University of North Carolina Health Care System, East Carolina University's Division of Health Sciences, customers of the North Carolina Turnpike Authority, or the North Carolina Department of Transportation shall be turned over to the Attorney General for collection no more than 90 days after the due date of the billing, except that a State agency need not turn over to the Attorney General unpaid billings of less than five hundred dollars (\$500.00) ...”

Please see Appendix 2 for a detailed list of past due invoices that were referred to the Attorney General's Office from April 1 – June 30, 2025.

**4. The number of temporary employees who exceeded 11 months of consecutive employment, and the number of days each employee exceeded 11 months of employment, separated by State agency.**

Background

From April 1 – June 30, 2025, approximately 8,421 temporaries were employed in state government. Of these, an average of 4,015 temporaries were employed through Temporary Solutions, an average of 1,952 were employed directly by state agencies, and 2,454 were employed through private staffing firms.<sup>3</sup>

N.C.G.S. § 126-6.3(a1) states: “No temporary employee shall be employed more than 11 consecutive months. A temporary employee shall only be eligible for reinstatement on the job assignment after working 11 consecutive months if the temporary employee is separated for at least 31 consecutive calendar days.”

N.C.G.S. § 126-6.3(a3) addresses exceptions to the 11-month requirement. Subsection (a3)(2) states: “A temporary employee who is a full-time student, a retired employee, an inmate on a work-release program, an intern, or an extern is exempt from the requirements of subsection (a1) of this section.” Subsection (a3)(3) states: “The Director of the OSHR may create exceptions to the requirements of subsection (a1) of this section only when all of the following conditions are

met: a. The exception is in the best interests of the State because removing the employee from the job assignment will cause severe harm to the agency's ability to provide vital services to the public. b. The exception will not result in extending the 11-month maximum length of temporary employment beyond 22 months from the employee's initial hire date.”

Table C identifies, by agency and employment method, the number of temporaries who worked more than 11 consecutive months without an approved exception.

In addition, 54 temporaries reached their 11-month limit between April 1 – June 30, 2025, but worked longer than 11 consecutive months because they had one of the approved exceptions in N.C.G.S. § 126-6.3(a3) (retired, a full-time student, intern, extern, inmate, or had an exception made under N.C.G.S. § 126-6.3(a3)(3)).

For a detailed list of temporaries who exceeded 11 months of continuous employment with an approved exception, please see Appendix 3. For a detailed list of temporaries who exceeded 11 months of continuous service without an approved exception, please see Appendix 4. These statistics are based on the data in the Integrated HR-Payroll System at the time of this analysis and may miss, until a later quarter, employees who did not have an employment action in the Integrated HR-Payroll System between April 1 – June 30, 2025.<sup>4</sup>

Relief from Temporary Employment Restrictions in the Disaster Recovery Act of 2024 (S.L. 2024-51; HB 149)

Section 12.2 of the Disaster Recovery Act of 2024 states: “Effective October 1, 2024, notwithstanding N.C.G.S. §126-6.3(a1), temporary employees, as defined by N.C.G.S. §126-6.3(c)(7), who are working to support disaster recovery response efforts are exempt from the mandatory separation requirement for the duration of the state of emergency related to Hurricane Helene or associated Hurricane Helene recovery efforts, as certified to the Office of State Human Resources by the employing agency. The provisions of N.C.G.S. §126-6.3(a4) contrary to this section will not apply and these employees may comply with the mandatory separation requirement within six months after the cessation of the state of emergency.”

<sup>4</sup> Temporary Solutions submitted an Office of State Controller (OSC) Change Control Board (CCB) request to create a new report in the Integrated HR-Payroll System that would allow Temporary Solutions and all state agencies to identify employees who were employed as of a date range. This would assist Temporary Solutions and all state agencies in determining the exact number of employees as of a date range, retroactively identifying temporaries with an exception who exceeded 11 months of continuous employment and separated prior to the generation of the report, and reducing the need for Temporary Solutions and all state agencies to rely on alternate methods of compiling data. Temporary Solutions also submitted a separate CCB request for a report that factors time data into the calculation of the 11-month limit date. OSC combined these two requests and created one query function in the Integrated HR-Payroll System to serve both purposes. Temporary Solutions has finished testing the 11-month limit date calculation function and, as of the writing of this report, is testing the “employees employed as of a date range” function.

Between April 1 – June 30, 2025, state agencies identified 84 temporary employees who were exempt from the mandatory separation requirement under Section 12.2 of S.L. 2024-51 because the employees were working to support disaster recovery response efforts, as certified to the Office of State Human Resources. For a detailed list of temporaries who were exempt from the 11-month mandatory separation requirement under Section 12.2 of S.L. 2024-51, please see Appendix 5.

### Notifications

N.C.G.S. § 126-6.3(a5) requires OSHR “to provide written notice to the agency at intervals of 90, 60, and 30 days prior to the temporary employee reaching 11 consecutive months of service.” For the two temporaries employed through Temporary Solutions who worked longer than 11 months without an approved exception, the employee and the agency received notifications prior to the employee reaching the 11-month limit at the intervals required in N.C.G.S. § 126-6.3(a5).

### Remediation

Agency employers provided an explanation for each temporary who worked longer than 11 months without an approved exception. Explanations specific to each temporary employee can be found in Appendix 4. Those comments are combined and summarized, with a corresponding remediation plan for each, in Table D below.

*For the workers paid through P & G Security Guard Inc.* — “The Department of Adult Correction has contracted with P & G Security Guard Inc. since 2021 to provide security to the perimeter of many of our state prisons. The employees of P & G are trained and supervised by P&G staff. P&G provides all staff uniforms and equipment to perform their job. Therefore, the agency has not viewed P&G as a staffing firm but an agency that provides a security service. Due to the nature of this contract the agency has not requested their employees take a 31-day break after 11 months. This requirement would make it very difficult for this company to retain their consistent trained staff.”

*For workers not paid through P&G Security Guard Inc.* — “Business operations dictated the need for continued work by the employee/work unit needed the employee to work longer than 11 months. These contracts were all competitively awarded Professional Services contracts and written as professional services contracts. The purpose was/is to augment DAC staff when additional needs arise. Contract language states the employees of this contract are employees of the vendor, and that the vendor will provide all obligations as the employer of Vendor Staff.”

*Health and Human Services Response:*

“Business operations dictated the need for continued work by the employee/work unit needed the employee to work longer than 11 months. [For nurses obtained through third-party staffing firms,] these contracts were all competitively awarded Professional Nursing Services contracts and written as professional services contracts. The purpose was/is to augment DSOHF Nursing staff when additional needs arise. Contract language states the employees of this contract are employees of the vendor, and that the vendor will provide all obligations as the employer of Vendor Staff.”

*Public Safety Response:*

“The Department of Public Safety is working to improve its tracking of third-party temporaries at Juvenile Justice and Delinquency Prevention (JJDP) facilities to ensure compliance with the 11-month limit.”
