INTRODUCTION

N.C.G.S. 126-6.3(a6) requires the Office of State Human Resources (OSHR) to report quarterly, beginning January 1, 2024, "to the Joint Legislative Oversight Committee on General Government and to the Fiscal Research Division on agency compliance with this section and policies and rules adopted pursuant to it, including:

- 1. The number and type of all exceptions made by the Director of the OSHR.
- 2. Any agency invoices with due dates greater than 60 days.
- 3. Compliance with G.S. 147-86.11(e)(3) through (e)(4).
- 4. The number of temporary employees who exceeded 11 months of consecutive employment, and the number of days each employee exceeded 11 months of employment, separated by State agency."

Temporary Solutions, a program of the Office of State Human Resources, hereby submits this report for the period July 1, 2023 through September 30, 2023.

COMPLIANCE REPORT

Prior to the 2023 Appropriations Act, G.S. 126-6.3(b), as previously written, required OSHR to report biannually on agency compliance with the section and policies and rules adopted pursuant to it. The 2023 Appropriations Act changed the reporting frequency to quarterly beginning January 1, 2024. The most recent biannual report was submitted in October 2023 and covered the period January 1, 2023 through June 30, 2023. This report covers July 1, 2023 through September 30, 2023. Going forward, so that OSHR and state agencies can work with complete and finalized employment and financial data and ensure the accuracy of all results, the time periods that will be covered in each quarterly report are as follows:

1. The number and type of all exceptions made by the Director of OSHR (G.S. 126-6.3(a6)(1))

Prior to the 2023 Appropriations Act becoming law on October 2, 2023, the Director of OSHR could create the following exceptions: 1) those authorized under G.S. 126-6.3(a), as previously written, regarding the required use of Temporary Solutions by Cabinet agencies, and; 2) those authorized under 25 NCAC 01A .0104 "where necessary to promote efficiency of administration and to provide for a fair and reasonable system of personnel administration."

The Director of OSHR made no exceptions under G.S. 126-6.3(a) or 25 NCAC 01A .0104 during the period July 1, 2023 through September 30, 2023.

On October 3, 2023, the 2023 Appropriations Act became law, including the new statute on exemptions, G.S. 126-6.3(a3). OSHR's next quarterly report, covering the time period from October 1 to December 31, 2023, will detail the implementation of the new exception statute.

2. Any agency invoices with due dates greater than 60 days (G.S. 126-6.3(a6)(2))

When a temporary is employed through and paid by Temporary Solutions, the employing state agency receives an invoice from Temporary Solutions that includes:

- The amount paid to the temporary.
- The employer portion of the FICA tax.
- The employer premium for High Deductible Health Plan coverage if the temporary is enrolled.
- An administrative charge of \$2.00 per hour of time worked by the temporary. The charge funds the operations of Temporary Solutions, a 100% receipt-supported program.

G.S. 147-86.21 requires state agencies to which an account receivable is owed to collect the account receivable according to internal policies and procedures that are consistent with statewide policies and procedures adopted by the State Controller. G.S. 147-86.11(e)(4) requires unpaid billings due to a state agency to be turned over to the Attorney General for collection no more than 90 days after the due date of the billing. Temporary Solutions issues past due notices to employing agencies when unpaid invoices are 30 days past due and 60 days past due. When an invoice is more than 60 but less than 90 days past due, Temporary Solutions sends employing agencies a letter notifying them that Temporary Solutions is required to refer unpaid invoices of at least \$50.00 to the Attorney General's Office for collection no more than 90 days after the due date of the billing.

Table A identifies, for the period ending September 30, 2023, the number of invoices that were more than 60 days past due, by agency. For a detailed list of these invoices, including the invoice number, state agency, number of days past due, and amount of each, please see Appendix 1.

As shown in Appendix 1, for the invoices that were over 60 days old, the average invoice amount was \$1,568.35.

Table A also identifies whether any of the past due invoices shown above required agencies to be suspended from acquiring new temporary employees under G.S. 126-6.3(a2). That statute, which became law October 3, 2023, reads,

"The OSHR shall prohibit from acquiring new temporary employees any agency or division, based on individual budget code, having an invoice owed to the OSHR that is over 90 days overdue and a total overdue invoice amount exceeding two hundred thousand dollars (\$200,000) for any number of days. When an agency is restricted from acquiring a new temporary employee under this subsection, the agency shall not be allowed to acquire new temporary employees through the Temporary Solutions Program until the agency has paid all overdue invoices. The provisions of this subsection do not apply to the North Carolina National Guard."

As shown above and in Appendix 1, none of the invoices that were over 90 days overdue were for a budget code that had a total overdue invoice amount exceeding two hundred thousand dollars (\$200,000) for any number of days.

3. Compliance with G.S. 147-86.11(e)(3) through (e)(4)

G.S. 147-86.11(e)(3) states: "Moneys due to a State agency by another governmental agency or by private persons shall be promptly billed, collected and deposited."

Temporary Solutions generates invoices prior to each biweekly pay day. This process typically takes one to two business days. Once the invoices are generated, they are distributed to each agency in SharePoint. This process typically takes five to seven business days.

Table B identifies, during the period July 1, 2023 to September 30, 2023, the pay period, the date of each biweekly pay day, the date that invoices were generated, and the date that invoice distribution was completed.

G.S. 147-86.11(e)(4) states:

Unpaid billings due to a State agency other than amounts owed by patients to the University of North Carolina Health Care System, East Carolina University's Division of Health Sciences, customers of the North Carolina Turnpike Authority, or the North Carolina Department of Transportation shall be turned over to the Attorney General for collection no more than 90 days after the due date of the billing, except that a State agency need not turn over to the Attorney General unpaid billings of less than five hundred dollars (\$500.00)...

In February 2023, there was a misunderstanding of instructions within OSHR regarding who was responsible for sending external communications to the Attorney General's Office regarding Temporary Solutions invoices 90 days past due. This oversight resulted in Temporary Solutions sending agencies "Notices of Pending Referral" notifying those agencies that invoices were approaching 90 days past due, but Temporary Solutions not referring those invoices to the Attorney General's Office. On December 7, 2023, the Temporary Solutions Manager recognized this gap in communication and compliance and corrected the process of referring past due Temporary Solutions invoices to the Attorney General's Office in accordance with G.S. 147-86.11(e)(4). The new process was implemented immediately. All invoices beyond 90 days as of December 19, 2023, have been referred to the Attorney General's Office and such invoices will continue to be referred to the Attorney General's Office in a timely manner. Additionally, as discussed above, at no point in the 3rd quarter of 2023 did any agency reach the threshold in statute that would require OSHR to prohibit the agency from acquiring new temporary employees.¹

¹ OSHR must prohibit an agency from acquiring new temporary employees if, based on individual budget code, they have an invoice owed to the OSHR that is over 90 days overdue and a total overdue invoice amount exceeding two hundred thousand dollars (\$200,000) for any number of days. G.S. 126-6.3(a2).

Background

From July 1, 2023 through September 30, 2023, approximately 9,034 temporaries were employed in state government. Of this, an average of 3,711 temporaries were employed through Temporary Solutions, an average of 3,717 were employed directly by state agencies, and 1,606 were employed through private staffing firms.² Under exceptions made by the Director of OSHR in June 2023 under G.S. 126-6.3(a) as previously written, five Cabinet agencies directly employed temporaries in addition to primarily using Temporary Solutions and three Cabinet agencies employed temporaries through private staffing firms in addition to primarily using Temporary Solutions.³

In March 2023, OSHR/Temporary Solutions implemented a notification process alerting temporary employees employed through Temporary Solutions or directly by a state agency that their 11-month limit was due within 30 days. The notifications are also sent to the employee's supervisor and HR Representative. Five of the six temporaries employed through Temporary Solutions who worked longer than 11 months without an approved exception received these notifications. One temporary did not receive a notification because they were identified as exempt (intern). The internship lasted beyond 11 months and the temporary continued to work once the internship ended.

Under the 2023 Appropriations Act, Temporary Solutions is now required to provide written notice to the agency at intervals of 90, 60, and 30 days prior to temporary employees reaching 11 consecutive months of service.

Temporary assignments are limited to 11 consecutive months unless an approved exception exists. An individual is eligible for reemployment as a temporary after working for 11 consecutive months if they are separated for at least 31 consecutive calendar days. Retirees, full-time students, interns, externs, and inmates are exempt from the 11-month limit. The Director of OSHR may also grant exceptions to the requirement.⁴

² The total number of temporaries employed through Temporary Solutions and directly by state agencies for past months is not available in the Integrated HR-Payroll System, only the total number that were employed at the end of each month. Therefore, an average number is provided. The average of 3,717 temporaries employed directly by state agencies includes 747 temporaries (actual) paid outside of the Integrated HR-Payroll System.

³ Cabinet agencies authorized to directly employ temporaries in addition to primarily using Temporary Solutions were the Department of Adult Correction, the Department of Health and Human Services, the Department of Information Technology, the Department of Public Safety, and the Department of Transportation. Cabinet agencies authorized to employ temporaries through third party staffing firms in addition to primarily using Temporary Solutions were the Department of Adult Correction, the Department of Health and Human Services, and the Department of Public Safety. The Department of Agriculture and Consumer Services, a Council of State agency, directly hired temporaries through an imprest accounting system and were not required to obtain OSHR approval to do so.

⁴ 25 NCAC 01C .0405 and the Temporary Employment Policy limit temporary assignments to 11 consecutive months unless the employee is retired, a full-time student, intern, extern or inmate. Under 25 NCAC 01A .0104, the Director of OSHR may create exceptions "where necessary to promote efficiency of administration and to provide for a fair and reasonable system of personnel administration." The 2023 Appropriations Act revised G.S. 126-6.3 to include the 11-month limit (subsection (a1)), exceptions for retirees, full-time students, interns, externs,

In addition, during the period July 1, 2023, through September 30, 2023, 152 temporaries had an exception to work longer than 11 consecutive months because they were retired, a full-time student, intern, extern, or inmate. For a detailed list of temporaries who exceeded 11 months of continuous employment with an approved exception, please see Appendix 2. For a detailed list of temporaries who exceeded 11 months of continuous service without an approved exception, please see Appendix 3. Due to limitations of the HR-Payroll System, these statistics

and inmates (subdivision (a3)(2)), and authority for the Director of OSHR to create exceptions to the 11-month limit when certain conditions existed (subdivision (a3)(3)).

are based on a manual analysis and may miss until a later quarter employees who did not have an employment action in the HR-Payroll System between July 1 and September 30, 2023.⁵

There were 80 temporary Security Guards employed by the Department of Adult Correction through private staffing firms for which compliance with the 11-month limit could not be determined during the drafting of this report because the start date of employment for each temporary was unknown to the agency. The agency explained that separating the Security Guards would risk safety and security at their assigned work locations. As this report was being finalized, DAC was working to determine the start dates of each of the temporary Security Guards so that their 11-month limits could be determined, 90/60/30-day notifications could be sent by Temporary Solutions where necessary, and their compliance with the 11-month limit could be included in the next quarterly report.

Remediation

Agency employers provided an explanation for each temporary who worked longer than 11 months without an approved exception. Those comments, which are combined and summarized, as well as a corresponding remediation plan for each, can be found below in Table C. Explanations specific to each temporary employee can also be found in Appendix 3.

⁶ Because the total number of temporaries employed through Temporary Solutions and directly by state agencies for past months is not available in the Integrated HR-Payroll System, Temporary Solutions worked with the Government Data Analytics Center (GDAC) to determine which temporaries reached 11 months of consecutive employment during the period July 1, 2023 through September 30, 2023 and continued to work after that date. Based on data provided by GDAC, only temporaries for which an employment action was completed in the Integrated HR-Payroll System during that period could be identified. Temporary Solutions compared this report to a roster of temporaries employed on December 20, 2023 whose 11-month limit was reached and exceeded between July 1, 2023 through September 30, 2023, and added those temporaries to the GDAC data. After compiling this list, it was determined that temporaries with an exception whose 11-month limit was reached and exceeded between July 1, 2023 through September 30, 2023 and separated from employment between October 1, 2023 and December 20, 2023 could not be identified using this method or with any report in the Integrated HR-Payroll System and are therefore not included in the total. Temporary Solutions is writing an Office of State Controller Change Control Board (CCB) request to create a new report in the System that would allow Temporary Solutions and all state agencies to identify employees who were employed as of a date range. This would assist Temporary Solutions and all state agencies in determining the exact number of employees as of a date range, retroactively identifying temporaries with an exception who exceeded 11 months of continuous employment and separated prior to the generation of the report, and reducing the need for Temporary Solutions and all state agencies to rely on alternate methods of compiling data.

G.S. 126-6.3(a5). Compliance with the 11-month requirement must be reported quarterly to the Joint Legislative Committee on General Government and to the Fiscal Research Division. G.S. 126-6.3(a6) A temporary employee is defined as "a State employee who is employed in a temporary appointment for a limited term, including a State employee hired from the OSHR Temporary Solutions Program, directly hired by an agency, hired by an agency from a private staffing firm, or hired by any other method used to fill a workforce need for a limited period of time." G.S. 126-6.3(c)(7)

Additionally, Temporary Solutions is working to develop an online compliance resource that will allow agency HR staff to view 11-month limit details for every temporary employed in their work unit in real-time and on-demand. The estimated launch date of the new system is Spring 2024. Email notifications will continue until and after this resource is launched.

Temporary Solutions will continue to maintain the Mandatory Separation Requirement page on its website (in place since 2022), require recommended candidates for temporary positions to certify in their onboarding packet that they understand and will comply with the 11-month requirement (in place since 2020), provide employees and their supervisors with the 11-month assignment end date in their completed onboarding confirmation email (in place since February 2023, previously communicated by the Placement Counselor at the time of hire and by the Temporary Solutions timekeeping staff prior to that), and collaborate with agency partners weekly to ensure that 11-month compliance related data in the Integrated HR-Payroll System is correct (in place since May 2023).

The temporary worked longer than 11 months under an approved exception (intern) and the temporary continued to work once the internship ended.

Historically, an intern has been defined as "students or recent graduates who, regardless of the number of credit hours enrolled, work to gain occupational experience for a short period of time, not to exceed three months." For the temporary in question, the internship exception ended three months after the 11-month limit, the temporary continued to work beyond the end of the exception. Whereas the definition of intern was only in 25 NCAC 01C .0405 and the Temporary Employment Policy, the 2023 Appropriations Act added it to statute and did so without a three-month maximum: "A student who, regardless of the number of credit hours enrolled, works to gain occupational experience for a period of at least one academic semester."

In December 2023, Temporary Solutions launched a new process in which a temporary identified as an intern at any point during their initial period of temporary employment will need to be recertified as an intern prior to reaching their 11-month limit. The end date of the internship will be recorded in the Integrated HR-Payroll System and Temporary Solutions will send notifications to the temporary, their supervisor, and their HR Representative prior to end of the exception. Temporary Solutions will recertify that a temporary employee still meets the requirements of the internship exception prior to the end date of the internship recorded in the Integrated HR Payroll System. Temporary Solutions also launched in December 2023 a new web portal in which state agency customers can request an extension to an existing exception by providing documentation supporting exception eligibility. In the case of an intern, this documentation may include recertification of student status or notification that the internship has been extended beyond the previously identified expiration date.
