

**TRANSITION TIMELINE –NEOGOV, PEOPLEADMIN, ORG PLUS, E-VERIFY TO WORKDAY**

Date	System	What's Happening
Now – August 31, 2025	PeopleAdmin	August 31 will be the last day to update job descriptions in PeopleAdmin and have the information migrated to Workday.
September 1 - 10, 2025	PeopleAdmin	<ul style="list-style-type: none"> <li>As of September 1, access is view-only, download any job descriptions you may need prior to Workday go-live.</li> <li>Access becomes inactive Sept 10 with contract expiration</li> </ul>
Now – October 1, 2025	NEOGOV	Continue using NEOGOV for requisitions and job postings with an end date not to exceed 5:00 pm on Tuesday Oct 7, 2025.
Oct 6 – Oct 7, 2025	Workday	<ul style="list-style-type: none"> <li>You may begin entering new requisitions in Workday with opening dates of Oct 8, 2025.</li> <li>Production security is live - it is recommended that you control the number of recruiters utilizing the system to align with the OSHR and agency Point of Contact (POC) support available.</li> <li>OSHR will provide an onsite location for agency POC plus one additional person to be in person, along with the project team, to support questions from your agency recruiters.</li> </ul>
Oct 7, 2025	NEOGOV	Last day for job postings to remain open (must close by 5:00 PM). Future new postings or reposts must go in Workday.
Oct 7, 2025	E-Verify	Last day to use agency-specific E-Verify MOUs and accounts. Further information forthcoming.
Oct 8, 2025	Workday	<ul style="list-style-type: none"> <li>Postings will be live Wednesday, Oct 8, 2025</li> <li>Communication will be sent from OSHR to all current NEOGOV candidates with information on how to create a profile and application in Workday</li> <li>I-9 &amp; E-Verify: Done in Workday - NEOGOV candidates must be entered directly into Workday for onboarding and hire.</li> <li>Advertisement and registration begin in Workday for the November 10<sup>th</sup> State Career Expo</li> </ul>
Oct 8, 2025	Job Seekers	NEOGOV's GovernmentJobs.com site becomes inactive. Job seekers redirected to the Workday Career Page.
Oct 24, 2025	NEOGOV	<ul style="list-style-type: none"> <li>Final day to screen and refer applicants from postings that closed on or before Oct 7.</li> <li>Last day to request NEOGOV user access.</li> </ul>
Nov 7, 2025	NEOGOV	Final day to interview applicants from postings that closed on or before Oct 7.
Nov 28, 2025*	NEOGOV/ Workday	<ul style="list-style-type: none"> <li>Final day for candidate selection from NEOGOV: reference checks, salary, offer extended, and acceptance complete.</li> <li>Candidates must be entered into Workday to complete their onboarding and hire.</li> </ul>
December 1, 2025	Org Plus	Org Plus will be removed from the Integrated HR/Payroll system environment/Fiori interface.
January 1, 2026	NEOGOV	System becomes read-only for select agency users (details forthcoming).

\*Dec 31, 2025-extended deadline for NEOGOV hires from continuous postings and/or for certified positions.
